## *Note regarding monthly drug plan premiums:* If you delay enrollment into Medicare Part D, you could pay more

You will have to pay a higher premium if you don't join a plan when you are first eligible or if you don't have an existing drug plan that is equal to or better than Medicare coverage (called "creditable coverage"). You will pay at least 1% more for every month you waited to get a Medicare prescription drug plan. The penalty is a percentage of the national average (**\$36.78 in 2025**) for Medicare drug plans. You will pay this higher premium for the rest of your life. Anyone who qualifies for Extra Help is not subject to a penalty.
